# Introductory Title

The Texas Child Care Centered System (T3C) services cover the changes needed to support the new placement model and service packages for Foster Family Care, General Residential Operations-Tier I (GRO I), and General Residential Operations-Tier II (GRO II). These service packages will include primary packages and add-on packages as follows:

- Foster Family Care has nine primary packages and three service Add-Ons.
- GRO-Tier I has nine primary packages.
- GRO-Tier II have six primary packages.

The current Supervised Independent Living (SIL) program remains a placement type under T3C using existing rate structure.

# Add-On Section Contd.

- A user can select all the 3 Add-Ons manually.
- The Add-On 'End Date' will auto populate same as the End Date of the Selected Primary Service Package when user enters an Add-On Start Date.
- Both the Start Date and the End Date of the Add-On service should be within the same time frame as the Primary Service Package.
- A user can modify the End Date by selecting an End Reason.

# Resource Credentialing

---

Service Package Credentialing is being developed in support of the new T3C service delivery model. As resources become credentialed to provide T3C services, service package credential records will be created and maintained to indicate which of the T3C services the resource is authorized or “credentialed” to provide.

- CPA’s will be credentialing their foster homes.
- HHSC will be adding credentials to the provider portal for the CPA to indicate credential status
- DFPS will receive that information via a CLASS batch to add to IMPACT.

**NOTE:** There is an upcoming change of the naming conventions for the services to change Facility to GRO I or GRO II.

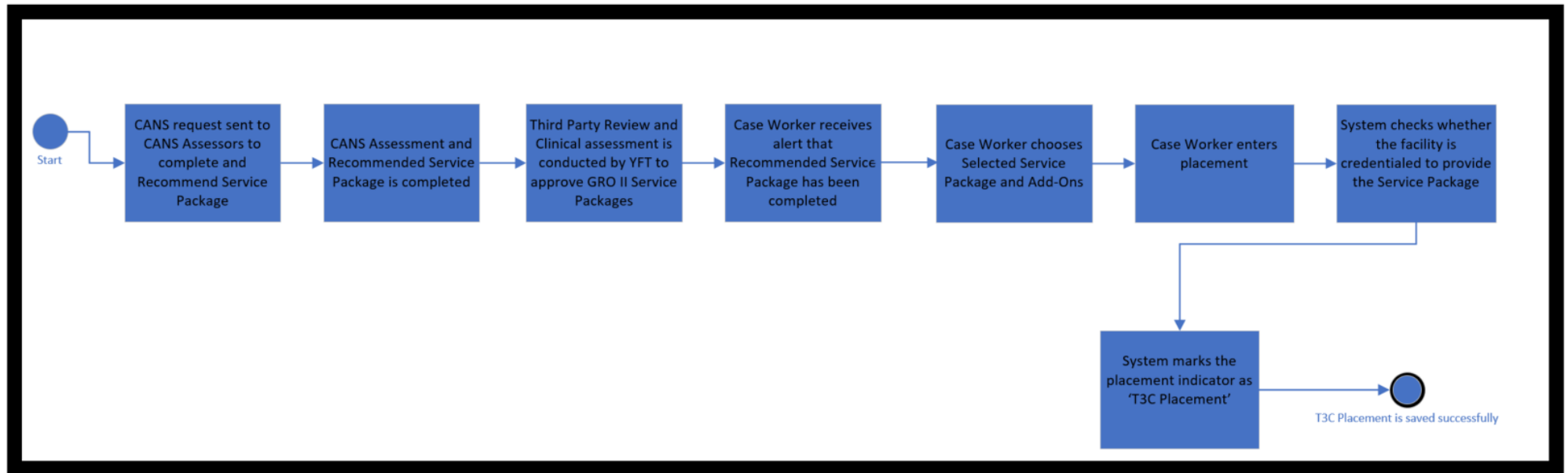

- Nightly T3C Transition Support Add-On Service Batch Job
  - A batch job will automatically add the transition service add-on to the service package when the child is between 14-22 and the caregiver is credentialed for T3C Transition Support Add-On Services.
  - The batch process will run on a nightly schedule.
- Nightly T3C Kinship Support Add-On Services Batch Job
  - A batch job will automatically add the kinship home service add-on to the service package when a child's placement indicates kinship and the caregiver is credentialed for T3C Transition Support Add-On Services.
  - The batch process will run on a nightly schedule.

**Note:** DFPS will be soliciting feedback from the SSCC's regarding new batch files to provide them information regarding the Recommended and selected service package page information and the credential status information for caregivers in their placement network.
